RULES

DRIBBLING

1. Contestant will start dribbling when the station monitor says GO!
2. Contestant must weave in and out of each flag and then go around the cone at the end. If a contestant misses a flag, he/she must go back around the missed flag.
3. After going around the cone, the contestant will dribble straight back to the starting line.
4. The clock stops when the contestant's whole body crosses the finish line.

PASSING

1. Each contestant will get three (3) passes from the starting point.
2. Passes are scored based on the distance between the flags. The greater the distance, the least amount of points.
3. If a pass hits a flag and goes through, points are awarded. If the pass hits a flag and bounces back, no points are awarded.
4. The ball must completely cross the plane for the points to be awarded.

SHOOTING

1. Each contestant will get three (3) shots from the starting point. The starting point will be determined by age.
2. Point values can be found on the front of this sheet in the "Shoot" category.
3. If a ball strikes between two different point totals, the lower of the two scores is awarded.

SCORING

The contest facilitators will have the final say on points awarded. **THERE WILL BE NO PROTESTS OF ANY KIND.**
